"The name and address of the Manager of the Company is:

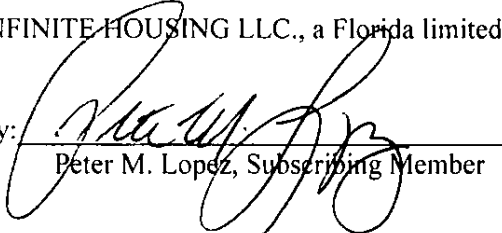

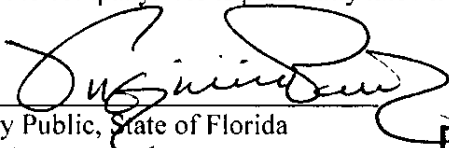
