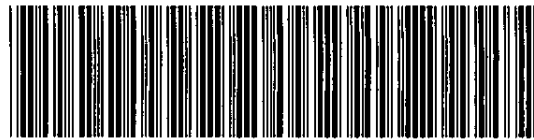

The following Articles of Organization are hereby adopted.

**ARTICLE I.  
Name**

The name of the Company shall be Suncoast Cancer Institute, P.L.L.C.

**ARTICLE II.  
Duration**

The Company shall exist perpetually.

**ARTICLE III.  
Address; Principal Office**
