ARTICLES OF ORGANIZATION FOR Y-BRIK PROPERTIES, LLC, A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability company under and pursuant to the PLORIDA Revised Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME.

ARTICLE II. ADDRESS.
