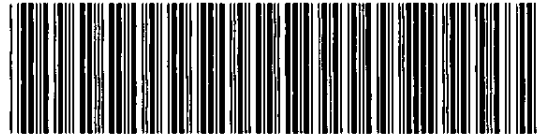

The name of the Limited Liability Company is "**SO WP CO-INVESTMENT, LLC**" (the "**Company**").


