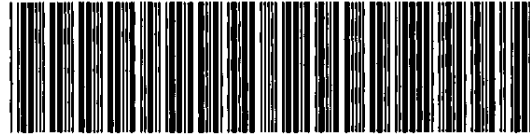

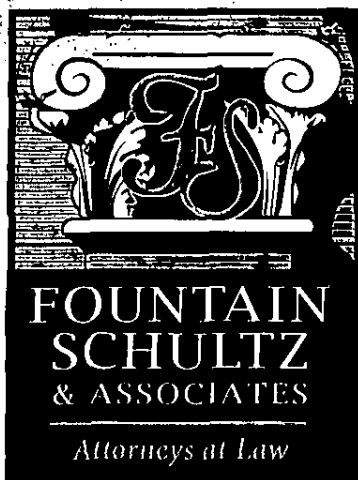

ARTICLES OF ORGANIZATION

OF


ARTICLE IX - MANAGEMENT


