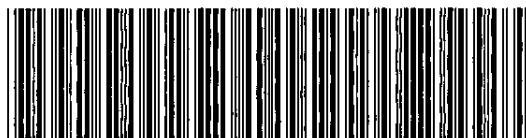

The name of the Company shall be: **NORDIC FOOD COMPANY OF CORAL SPRINGS, LLC.**


**ARTICLE II**
