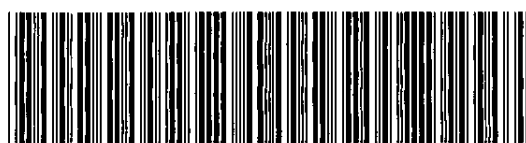

The name of the Company shall be: **NORDIC FOOD COMPANY OF HOLLYWOOD, LLC.**

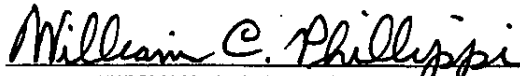
ARTICLE II
