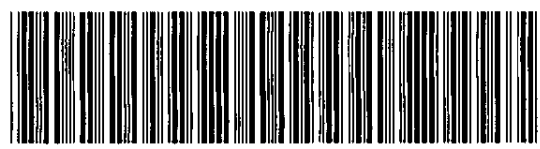

**ARTICLES OF ORGANIZATION  
OF

**Article 4. - Registered Office & Agent**


