ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF CCRE RELIGIOUS & EDUCATIONAL REAL ESTATE, LLC

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, CCRE RELIGIOUS & EDUCATIONAL REAL ESTATE, LLC adopts the following Articles of Amendment to its Articles of Organization:
