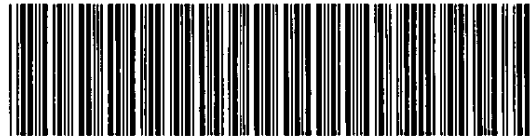

**FIRST AMENDMENT TO ARTICLES OF ORGANIZATION
OF
LBI DEATH CARE MANAGER, LLC
(hereafter to be known as Journey Fund I GP, LLC)**

The Articles of Organization of LBI Death Care Manager, LLC, a Florida limited liability company (the "Company"), filed with the Division of Corporations of the Florida Department of State on September 29, 2015 (the "Articles of Organization"), are hereby amended pursuant to Fla. Stat. § 605.0202(2), as set forth in this First Amendment to Articles of Organization (this "Amendment").

1. Name and Document Number. The name of the Company immediately prior to the filing of this Amendment is LBI Death Care Manager, LLC, and its document number on file with the Division of Corporations of the Florida Department of State is L15000165899.

2. Amendment to Article I. Article I of the Articles of Organization is hereby amended in its entirety to read as follows:

"The name of the limited liability company is Journey Fund I GP, LLC (the "Company")."

3. Amendment to Article II. The street address of the Company listed in Article II of the Articles of Organization is hereby changed to 455 NE 5th Avenue, D-337, Delray Beach, Florida 33483.

4. Amendment to Article IV. Article IV of the Articles of Organization is hereby amended in its entirety to read as follows:

"The name and street address of the Company's registered agent for service of process in the State of Florida is Corporate Creations Network, Inc., 11380 Prosperity Farms Road #221E, Palm Beach Gardens, Florida 33410."

5. Effective Date of Amendment. This Amendment was adopted and shall be effective on May 16, 2016.

6. Effect of Amendment. The Articles of Organization shall remain in full force and effect except as expressly modified by this Amendment.
