## ARTICLES OF ORGANIZATION FOR VIVID FACE, LLC

### ARTICLE I - NAME

The name of the Limited Liability Company is VIVID FACE, LLC.

## **ARTICLE II - ADDRESS**

Each manager shall serve until the first annual meeting of the members of the Limited Liability Company of until their successors are elected and qualify. ## ARTICLE IX - AMENDMENT OF ARTICLES OF ORGANIZATION

A majority of the members owning Member Units may consent to an amendment to the Articles of Organization.

# **ARTICLE X - INDEMNIFICATION**

The Limited Liability Company shall indemnify any member, manager or officer of the Limited Liability Company, or any former member, manager or officer of the Limited Liability Company, to the fullest extent permitted by law.
