AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF

KEITHIAN ENTERPRISES GROUP, LLC

The Articles of Organization for this Limited Liability Company were filed on September 28, 2015 and assigned Florida document number L15000165922. These articles replace and restate the original articles.

Pursuant to the provisions of section 605.0202, Florida Statutes, this *Florida Limited Liability Company* adopts the following Amended and Restated Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company ("LLC") is: **Keithian Enterprises Group, LLC.**

ARTICLE II - DURATION

The existence of the LLC shall be perpetual and shall begin on the date that the articles of organization were filed with the Florida Department of State.

The LLC is to be managed by the Members, and the names and addresses of the Members/Managers are as follows:

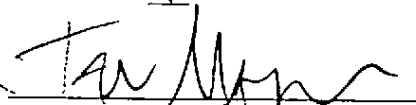
