

NEW MEMBERS**





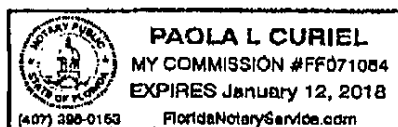
