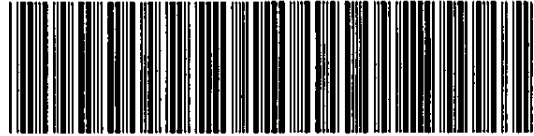

ARTICLES OF ORGANIZATION OF STRATFORD DRIVE, LLC

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

NAME AND MAILING ADDRESS & STREET ADDRESS OF PRINCIPAL OFFICE

The name of the limited liability company shall be STRATFORD DRIVE, LLC, [hereinafter the "Company"] and its principal office's street address shall be 2335 Lorena Lane, Clearwater, FL 33765 and its mailing address shall be 2335 Lorena Lane, Clearwater, FL 33765, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

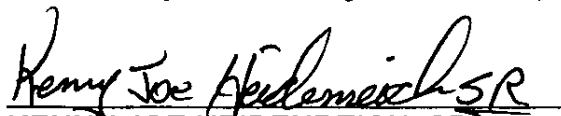

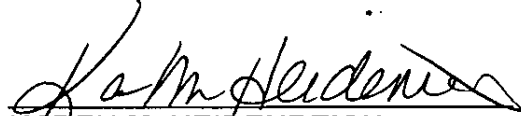
