The undersigned, for the purpose of restating and amending the articles of organization for GFI FINANCIAL, LLC, formed pursuant to the Florida Limited Liability Company Act, F.S. Chapter 605, on October 5, 2015, hereby make, acknowledge, and file these Restated and Amended Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is GFI FINANCIAL, LLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal place of business of the Limited Liability Company is 150 S.E. 2nd Avenue, Suite #1010, Miami, Florida 33131.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to operate the business of GFI FINANCIAL, LLC, and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company as may be required pursuant to a vote of the majority-in-interest of the members.

ARTICLE VI - ADMISSION OF NEW MEMBERS

New members shall be admitted to the Company as may be authorized pursuant to a vote of the majority-in-interest and upon such terms and conditions as shall be determined by the majority-in-interest of the members. The majority-in-interest of members shall determine the amount and nature of contributions by new members at the time new members are admitted.

ARTICLE VII - CONTINUATION OF BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued by a vote of the majority-in-interest of members; in absence of which the Company shall be dissolved.

ARTICLE VIII - MANAGEMENT

The Company shall be managed by the manager(s) in accordance with the operating agreement adopted by the members for the management of the business and affairs of the Company, if applicable or as determined by a majority-in-interest vote of the members. This operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law and these Restated and Amended Articles of Organization. 
