**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **FGS BOAT, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **4389 45<sup>th</sup> St. S., St. Petersburg, Florida 33711.**

The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
