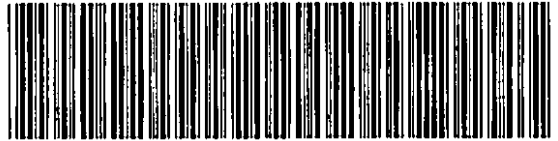


SECOND: The following amendments to the articles of organization were adopted by the limited liability company at a duly called meeting held on January 10, 2022:
