**ARTICLES OF ORGANIZATION
FOR
CANAL CROSS, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the organizer of CANAL CROSS, LLC ("Company"), under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is CANAL CROSS, LLC.

**ARTICLE II
PURPOSE AND POWERS**

A. **Purposes.** The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 605, Fla. Stat., as the same may be amended from time to time.
