Agreement"), the business and affairs of the Company shall be managed by or under the direction of the manager. The initial manager shall be: **Henry B. Burroughs, III.**

**ARTICLE VI
OPERATING AGREEMENT**

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

REGISTERED OFFICE AND REGISTERED AGENT**
