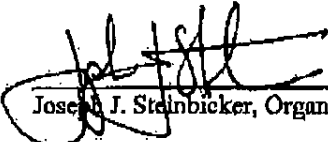

MANAGEMENT**

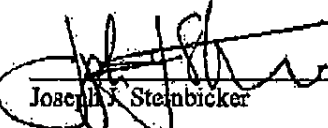
