**FOURTH:** Article III of the Articles of Organization of the Company, as amended, is hereby amended, in its entirety, as follows:

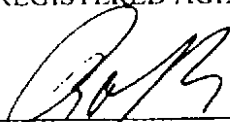

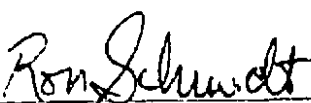
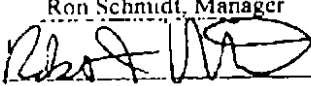
The foregoing amendment to the Company's Articles of Organization will become effective upon the filing of these Articles of Amendment to the Articles of Organization with the Florida Department of State.
