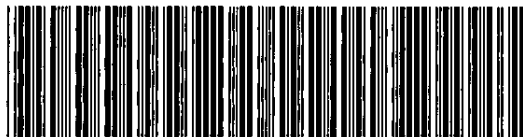

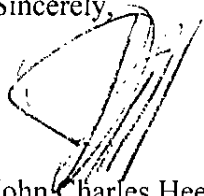

The undersigned subscriber, NAIM AD-DEEN, a natural person competent to contract, herewith files these Articles of Organization pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes for such organization.

ARTICLE ONE. Name.

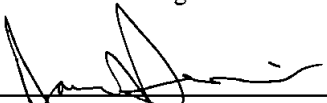

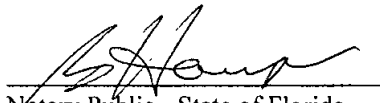
