## ATTACHMENT- ARTICLE VI

- Except as provided by the Florida Limited Liability Company Act Section 1. 605,0407, the members of this limited liability company shall not be managers by virtue of their status as members and the company shall be manager-managed.
- . 2. To the fullest extent permitted by the Florida Limited Liability Company Act, as it exists or may hereafter be amended, the limited liability company shall indemnify all members and managers of the limited liability company against all liability and litigation expense, including, but not limited to, reasonable attorney's fees, arising out of their status as such or their activities in the foregoing capacity, regardless of when such status existed or activity occurred and regardless of whether or not they are members or managers of the limited liability company at the time such indemnification is sought or obtained. Without limiting the generality of the foregoing indemnity, such persons may also recover from the limited liability company all reasonable costs, expenses, and attorney's fees in connection with the enforcement of rights to indemnification granted herein. The provisions of this paragraph are in addition to and not in limitation of the power of the limited liability company with respect to, and the rights of any manager or member of the limited liability company to receive the benefits of, any other or further indemnification, insurance, elimination of liability or the right or benefit which is either required by the Florida Limited Liability Company Act or permitted thereby and duly adopted by the limited liability company in accordance therewith.
- To the fullest extent permitted by applicable law, as it now exists or may hereafter 3. be amended, no member or manager of the limited liability company shall have any personal liability arising out of any action, whether by or in the right of the limited liability company, or otherwise, for monetary damages for breach of his or her duty as a manager or member. This
