

- 1 Since October, 10, 2015 when FORSTER INVESTMENTS LLC has begun a partnership with MOBI PRONTO LLC there were no commitment to get revenues by MOBI PRONTO LLC's CEO, Mr. Pedro José de Barros Rego.
- 2 In middle of August 2016, Mr. Pedro José de Barros Rego <u>abandoned</u> the MOBI PRONTO LLC operation and moved out to work for a company in Boston. He paralyzed all operations and as a result the company has stopped working;
- 3 Mr. Pedro José de Barros Rego changed MOBI PRONTO LLC's PayPal accesses, and also changed passwords from GoDaddy without his partners permissions, those places have all website domains which belong to the corporate, thus FORSTER INVESTMENTS LLC cannot access its accounts and it generated chaos and insecurity in the US operation.
- 4 So I, Flávio Misk Forster, only member of FORSTER INVESTMENTS LLC, totally lost confidence in Mr. Pedro José de Barros Rego, the MOBI READY LLC Manager and therefore, today, September 1st 2016, I request resignation of FORSTER INVESTMENTS LLC to the ownership structure of MOBI PRONTO LLC.
