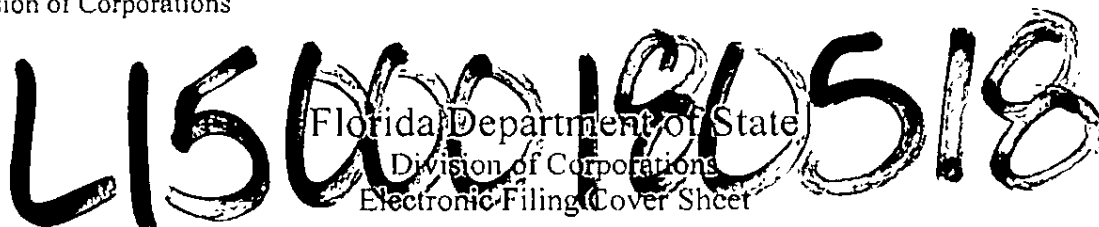

- SIXTH: The Articles of Amendment shall be effective upon their filing with the Florida Department of State.

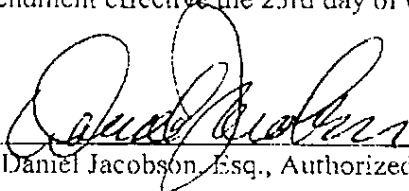
