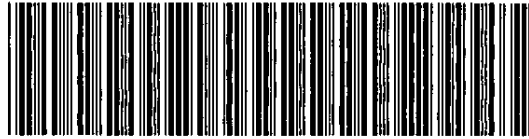

Article VI - PURPOSE


