**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Gainesville Wellness and Performance, LLC (the "Company"). The Company's principal address and mailing address is 220 NW 26th Street, Gainesville, Florida 32607. The Company's initial registered agent is David M. Jeffries, whose address is 1227 N. 




