**Registered Agent and Office**



**Management of Business**

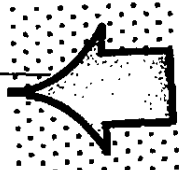

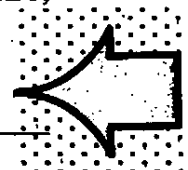
