**ARTICLES OF ORGANIZATION
OF
GIESEN HOLDING, LLC**

The undersigned, Gwendolyn C. Giesen, a natural person competent to contract and an authorized representative of Giesen Holding, LLC, hereby presents these Articles of Organization as the Articles of Organization of Giesen Holding, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Giesen Holding, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 558 Mooney Road, Ft. Walton Beach, Florida 32547.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE VI - MANAGEMENT




