ARTICLE I

The name of the limited liability company shall be **LYNN LAWN SERVICES, LLC** (the "Company").

ARTICLE III

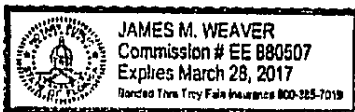
