NOONAN III, a natural person competent to contract and an authorized representative of NOONAN GENERAL, LLC, hereby presents these Articles of Organization as the Articles of Organization of NOONAN GENERAL, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is NOONAN GENERAL, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the Company's initial principal office is 1225 E. Blount St., Apt. #1, Pensacola, FL 32503. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.


**ARTICLE V - REGISTERED OFFICE AND AGENT**


