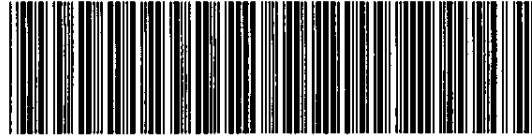

This Limited Liability Company was formed, upon the filing of the original Articles of Conversion and Articles of Organization with the Florida Secretary of State (Florida document number L15000185090). These Amended and Restated Articles of Organization shall supersede the original Articles of Organization, which have not been previously amended. The Articles of Organization are hereby amended and restated in full as herein set forth:

ARTICLE I
NAME

The name of the Limited Liability Company is amended and shall now be known as **ZOHLMAN BROTHERS, LLC** (the "Limited Liability Company").

ARTICLE II
ADDRESSES
