**ARTICLES OF ORGANIZATION

The undersigned, Frank L. Flautt, III, a natural person competent to contract and a member of F3, LLC, hereby presents these Articles of Organization as the Articles of Organization of F3, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is F3, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


