**ARTICLES OF ORGANIZATION
OF

The undersigned, J. Carson Patrick, a natural person competent to contract and a member of Joseph Carson Patrick LLC, hereby presents these Articles of Organization as the Articles of Organization of Joseph Carson Patrick LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Joseph Carson Patrick LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

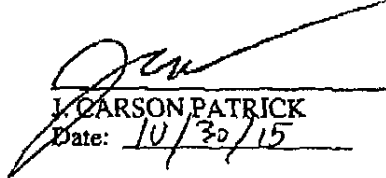

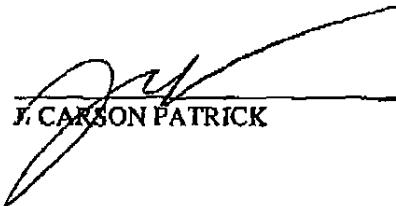
