**ARTICLES OF ORGANIZATION
OF
TEXAR GENERAL, LLC**

The undersigned, RICHARD N. SHERRILL, a natural person competent to contract and an authorized representative of a member of TEXAR GENERAL, LLC, hereby presents these Articles of Organization as the Articles of Organization of TEXAR GENERAL, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TEXAR GENERAL, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the Company's initial principal office is 410 East Government Street, Pensacola, Florida 32502; and the mailing address is P.O. Box 12316, Pensacola, Florida 32591. The Company's principal office may hereafter be at such other place or places as the member from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT


The address of the initial registered office of the Company in the State of Florida shall be 125 West Romana Street, Suite 800, Pensacola Florida 32502, of which the mailing address is P.O. Box 13010, Pensacola, Florida 32591, and the name of the registered agent of the Company at that address is RICHARD N. SHERRILL.

ARTICLE VI – MANAGEMENT

The Company shall be managed by a manager who shall be appointed, removed or replaced by the member in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial manager of the Company who shall serve as the initial manager until successors are elected or otherwise appointed in accordance with the Operating Agreement of the Company are as follows:
