ARTICLES OF ORGANIZATION OF TEXAR GENERAL, LLC

The undersigned, RICHARD N. SHERRILL, a natural person competent to contract and an authorized representative of a member of TEXAR GENERAL, LLC, hereby presents these Articles of Organization as the Articles of Organization of TEXAR GENERAL, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is TEXAR GENERAL, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the Company's initial principal office is 410 East Government Street, Pensacola, Florida 32502; and the mailing address is P.O. Box 12316, Pensacola, Florida 32591. The Company's principal office may hereafter be at such other place or places as the member from time to time may determine.

ARTICLE III - PURPOSES AND POWERS
