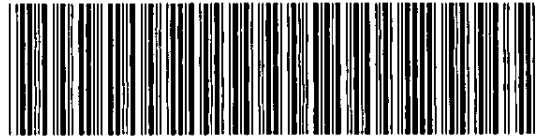

TO

Pursuant to the provisions of Section 605.0202, Florida Statutes, **EMERALD COAST DIGESTIVE DISEASE SPECIALISTS, LLC**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: Articles I and II of the Company's Articles of Organization have been amended to read as follows:
