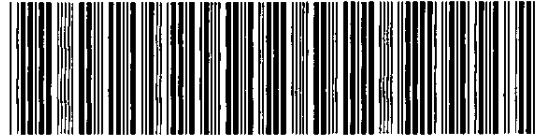

ARTICLE III– Registered Agent and Office




