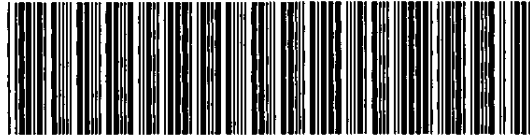

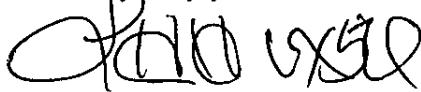

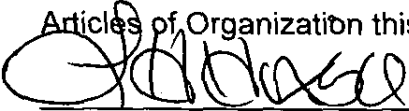
ARTICLE VIII - MANAGEMENT
