## ARTICLES OF ORGANIZATION

OF

### ROCKMAR HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be **ROCKMAR HOLDINGS, LLC** ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1631 Rock Springs Road, #373, Apopka, Florida 32712 and the mailing address shall be the same.




