ARTICLES OF ORGANIZATION OF

### ARTICLE I NAME

The name of this Limited Liability Company shall be BADAJOZ INVESTMENTS LLC, the Company).

No additional members shall be admitted to the Company and no member may transfer his or her interest in the Company, except, in either case as set forth in the Regulations, and if there are no Regulations then in effect, by unantmous consent of all of the members.
