**ARTICLES OF ORGANIZATION

The undersigned, Wade Howell, a natural person competent to contract and a member of Howell Investments of Northwest Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of Howell Investments of Northwest Florida, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Howell Investments of Northwest Florida, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."




