**ARTICLES OF ORGANIZATION
OF
CASA CORSICANA, LLC**

1. **Name.** The name of this limited liability company is **CASA CORSICANA, LLC**, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. **Purpose.** The purpose for which the Company is organized is to consist solely of the acquisition, ownership, operation, maintenance and management of the Casa Corsicana Apartments, consisting of that certain real property and improvements located at 12430 Rose St., Seminole, Pinellas County, Florida and such activities as are necessary, incidental or appropriate in connection therewith.
