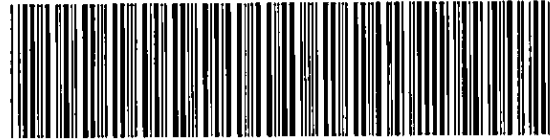

**AMENDED  
ARTICLES OF ORGANIZATION  
OF  
THE DAQ SHACK & PACKAGE STORE, LLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, the undersigned desiring to amend and restate the articles of organization of THE DAQ SHACK & PACKAGE STORE, LLC, a limited liability company (the "Company") duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on March 24, 2020 and assigned document number L15000195610. The undersigned confirms that these Amended and Restated Articles of Organization were unanimously adopted by the Managers of the Company by a Written Consent of the Meeting of the Managers of the Company on October 6, 2016. The following Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

**ARTICLE I**

**NAME**

The name of the limited liability company is THE DAQ SHACK & PACKAGE STORE, LLC (the "Company").

**ARTICLE II**

**ADDRESS**

The principal office and mailing address of the Company is:

**ARTICLE III**

**REGISTERED AGENT AND OFFICE**

The Company designations 1754 Wells Road, Orange Park, FL 32073 as the street address of the initial registered office of the Company and names Mills Legal Service, P.A. as the Company's registered agent at that address to accept service of process within this state.

## **ARTICLE IV**

### **DURATION AND CONTINUATION**

The period of the Company's duration commenced upon the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by written agreement of a majority of ownership interest.

## **ARTICLE V**

### **MANAGEMENT**

The Company shall be conducted, carried on, and managed by at least one (1) Manager. The Manager shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The Manager shall serve in such capacity until their successor(s) are duly elected and qualified.

## **ARTICLE VI**

### **PURPOSE**

Additional Members may be admitted upon the written consent of the majority ownership interest, and upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company, if applicable.

## ARTICLE IX

### OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Member(s) of the Company in the manner set forth in the Operating Agreement of the Company, if any.
