ARTICLE 8

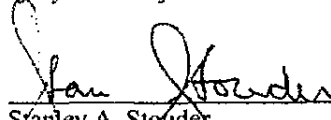

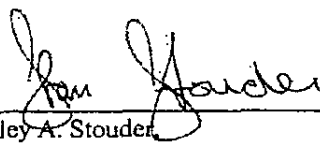
