The undersigned hereby submits these Articles of Organization (the "*Articles of Organization*") for purposes of forming Pensacola Technology Group, LLC (the "*Company*") under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I - Name

The name of the limited liability company is Pensacola Technology Group, LLC.

ARTICLE II - Address

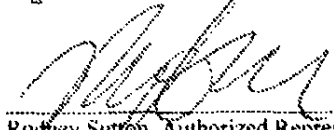
