## ARTICLES OF ORGANIZATION OF LEE LOGISTICS, L.L.C.



- 1. <u>Name</u>. The name of the limited liability Company (hereinafter referred to as "Company") is: LEE LOGISTICS, L.L.C.
- 2. <u>Existence</u>. The Company shall have perpetual existence commencing with the date of filing.


