The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be 6958, LLC (the "Company").

ARTICLE II -- ADDRESS

- (a) The principal address of the Company shall be 13967 SW 119th Avenue, Miami, FL 33186.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

The Operating Agreement and/or Regulations, if any, or otherwise the minutes of the Company, shall determine the manner in which such Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law or these Articles of Organization.
