The name of this Limited Liability Company is SOUTHWINDS REAL ESTATE INVESTMENTS, LLC.



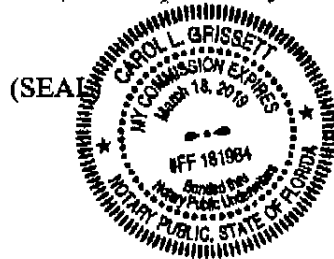
