**ARTICLES OF ORGANIZATION
OF
4R CAPITAL LLC**

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is 4R Capital LLC (the "Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company are 2800 Biscayne Boulevard, Suite 310, Miami, Florida 33137.

ARTICLE III. REGISTERED AGENT AND OFFICE




